TERMS OF USE

For the documentary collections, scanning can be done on demand [[see fees](#)].

For high quality publications we advise you to avoid re-use and always order the latest image version via the RMFAB.

1. Terms:

- ✓ Image and reproduction requests will be processed administratively within 10 working days after receipt of this request form
- ✓ If the application is incomplete or formulated too vaguely, you will be asked to complete it. If the required information is not provided within 20 working days, the request will automatically be cancelled.
- ✓ For extensive or complex requests, the processing time may be extended by 20 working days. In this case the RMFAB will inform the applicant.
- ✓ Image files will be transferred via a URL within 20 working days after receipt of the proof of payment (if applicable). Given the digital nature of the images sent, no order can be cancelled after delivery.

2. The applicant undertakes to send one printed copy of the publication or a digital copy (PDF) in the case of an e-publication, in each language in which it appears, to the museum library [*RMFAB Library, attn. Ingrid Goddeeris, Museumstraat 9, 1000 Brussels or ingrid.goddeeris@fine-arts-museum.be*]. In this way you can contribute to the unique function of the museum as a research and information centre.

3. Copyright and source reference:

- ✓ The research community appreciates acknowledgement of the source (*RMFAB, Brussels*). If possible, please also mention the artist/author, the identification number of the object and the photographer.
- ✓ If the artist/the author of a text document or image document is still alive or died less than seventy years ago, the artist/author of the document, his heirs or legal representatives may claim copyright on the reproduction of the work of art/document. More information on how to arrange the right of use can be found, among other things, on the [UNISONO](#) website.
- ✓ The RMFAB indemnifies itself against all third-party claims regarding the copyright or other rights, associated with the works whose reproductions were provided to the requestor.
